### CAGES FOR PHYSICAL SECURITY AND REGULATORY COMPLIANCE.

When you choose an Interxion data centre to house your equipment, you can rely on our highly secure facilities with exceptional levels of power availability, redundancy and connectivity.

Power resilience, exceptional connectivity, and security underpin all of our colocation products for the benefit of enterprises, cloud and service providers of all sizes. We offer a range of equipment housing options from individual Cabinets, to Cages and Private Rooms which provide extra layers of security.

Our products are standardised across all of our data centre campuses, so whether you locate in one facility or have an international deployment you can rely on the same functions, security and service levels across our European footprint.

A Cage is a physical barrier erected around the installation of Cabinets leased by a single customer. Private and Shared Area Cages provide the additional levels of physical security required by regulatory compliance and the need for increased segregation from other tenants in the data centre.

Both options include an extension of the barrier beneath the raised access floor to the floor slab, preventing any under-floor incursion, and an option to extend the barrier to the ceiling slab.

Our environmental controls and SLAs conform to ASHRAE 2011 guidelines for computing efficiency, performance, equipment availability, energy efficiency and PUE optimisation.

### Interxion Cages

- **Security.** Layered physical access control, locking Cabinets with fully enclosed sides, Cages that extend slab-to-slab, metal mesh or metal panel wall options.
- **Energy efficiency.** Cold aisle containment, full blanking panels, sealed floor openings for optimised airflow management and PUE control.
- **Robust service levels.** Environmental guarantees according to ASHRAE 2011 inlet temperature and humidity specifications.
- **Feature rich.** Pan-European availability, broad selection of power options, support from our Hands & Eyes service.

Our award winning colocation infrastructure provides a secure mission critical facility foundation for enterprise companies, cloud and service providers. Our data centres have attracted a diverse customer base, creating communities of interest. These bring together companies operating in the same sector so that they can benefit from fast and low-cost interconnectivity and establish valuable business relationships.

Cages provide physical barriers which separate customer's Cabinets from all other activity on the data centre floor. They restrict all physical proximity to any surface of the enclosed Cabinets. All Cage doors have security locks which are managed under our stringent access control policies. Our Private Cage option also includes solid metal panels that obscure visual inspection of their contents from outside as well as a dedicated power distribution point.

- Custom dimensions are based upon the needs of the equipment installation, intended use of the space, and on specific industry guidelines
- Secure metal fencing material provides a secure barrier against disturbance of the enclosed environment
- Satisfying the strictest regulations. Cage barriers extend to the floor slab beneath the raised access floor, and can extend up to the ceiling slab. Our Private Cages uses solid metal panels to obscure visual inspection of the Cage contents
