Strategic Location for Latency Advantage

Interxion's London data centre campus sits right between the Square Mile, the centre of global finance, and Tech City, the 3rd largest technology start-up cluster in the world. Its geographical proximity to the London Stock Exchange, equidistant between the key hosting centres of Slough (BATS, EBS) and Basildon (ICE Futures, Euronext), and access to microwave connectivity to Frankfurt (Eurex) make it unequalled in terms of European trading venue access. This central location yields major speed advantages for multi-venue trading strategies and enables optimal order book aggregation / consolidation for best execution under MIFID II.

Community is Key for MiFID II Compliance

Interconnectivity within your chosen data centre is key to effective trading execution. Interxion's 200+ capital markets participants, colocated at Interxion's London Data Centre Campus, can directly connect to key pools of liquidity, such as the London Metal Exchange and Equiduct, and have access to all the major low latency connectivity PoPs to Europe's major exchanges, MTFs and broker routing systems. The value of being part of this community goes beyond mere access to liquidity: community members have access to market data providers, brokers, low latency network providers and public cloud access points. Add to this, Interxion's community of ISVs, offering a range of services from time synchronisation, time stamping and order aggregation, to pre- and post-trade risk controls, and it is clear to see how being part of this community facilitates high performance trading and MiFID II regulatory compliance.
